1. Act of September 24, 1789 (1 Stat. 81, § 13, in part). Provision that "[the Supreme Court] shall have power to issue . . . writs of mandamus, in cases warranted by the principles and usages of law, to any . . . persons holding office, under authority of the United States" as applied to the issue of mandamus to the Secretary of State requiring him to deliver to plaintiff a commission

The Marshall Court refers to the Supreme Court of the United States from 1801 to 1835, when John Marshall served as the fourth Chief Justice of the United States. Marshall served as Chief Justice until his death, at which point Roger Taney took office. The Marshall Court played a major role in increasing the power of the judicial branch, as well as the power of the national government.

### **Acts of Congress Held Unconstitutional in Whole or in Part**

The Court ruled that the state had no interests in a woman's pregnancy in the first trimester and the woman thus had a right to terminate the pregnancy. The decision remains the most controversial of the Supreme Court's rulings in the US.
