The New Mexico Supreme Court is the State's highest court and final court of review (court of last resort). In addition to reviewing decisions of lower courts, the Supreme Court, as the head of the Judicial Branch of Government, has general administrative and supervisory authority over all State courts and attorney regulation. NM Courts Home Chief Judicial Magistrate/Chief Metropolitan Magistrate exercises supervisory authority or administrative authority of all the magistrates in sessions/division or metropolitan areas.
